Agenda 3 To report the financial statements of WHART Trust for the year 2018

Objective and Rationale

The REIT Manager prepared WHART Trust's financial statements for the fiscal year 2018 ended 31 December 2018 which were audited and certified by the auditors and which appeared in the annual report for the year 2018 and Enclosure 2 with the following summary:

Balance Sheet as of 31 December 2018

WHART Trust has total assets in the amount of approximately Baht 32,651.32 million and total liabilities in the amount of approximately Baht 10,667.99 million. The net asset value is Baht 21,983.33 million. The net asset value consists of the equity from Trust Unitholders and the accursed profit in the amount of Baht 21,624.47 million and Baht 358.86 million respectively.

Income Statement for the period from 1 January 2018 to 31 December 2018

WHART Trust has total income in the amount of approximately Baht 1,979.93 million and total expenses in the amount of Baht 335.82 million. Therefore, WHART Trust has the net income before financial costs and net gain (loss) from investment in the amount of Baht 1,644.11 million. After deducting financial costs in the amount of approximately Baht 334.42 million and adding back net gain from investments in the amount of Baht 163.32 million (out of which Bath 160.52 million is the net unrealized loss from investment valuation), WHART Trust has increase in net assets from operations during the year (net profit) in the amount of approximately Baht 1,473.01 million.

The REIT Manager considered it appropriate to propose to the Meeting of the Trust Unit Holders to acknowledge the financial statements for the fiscal year 2018.

Remuneration of the auditors for the year 2019 is Baht 1,130,000 (exclusion of expenses).
